Deed of Discharge, Release and Indemnity

- 1) The member agrees to abide by the rules of World Health Organization at all times.

- 3) Indemnity: The member indemnifies WHRO against all claims for any loss sustained.

- 5) Bar to Action: The candidate agrees that this deed may be pleaded as a bar to any action, suit or proceeding taken at any time by the candidate against WHRO arising out of or as a consequence of WHRO or any incidental activities.
